THIS IS A CALL FOR CIVILIZED AND LAW ABIDING PEACEFUL NATIONS OF THE WORLD WHO UNDERSTAND THAT NEW INTERNATIONAL BODIES OF ENFORCEMENT AND A NEW FORM OF INTERNATIONAL LAW IS NEEDED TO STOP THE WANTON ILLEGALITY OF CERTAIN NATIONS AND THEIR ALLIES.

THESE ROGUE NATIONS ARE CHIEFLY THE ILLEGAL APARTHEID STATE OF ISRAEL, THE ILLEGAL STATE FOUNDED ON GENOCIDE NAMED THE UNITED STATES OF AMERICA AND THE KINGDOM OF SAUDI ARABIA, NOT IN FACT A COUNTRY BUT A KINGDOM. THIS TRIO HAVE EMBARKED ON AN ILLEGAL AGGRESSIVE MILITARY TAKEOVER OF THE WORLD AND TOGETHER WITH THEIR ALLIES AND CLIENT STATES, THROUGH THE USE OF TERROR, GENOICDE AND AGGRESSIVE WAR, SOMETIMES MASKED AS HUMANITARIAN INTERVENTION, HAVE VIOLATED EVERY TENET, INTERNATIONAL NORM AND STANDARD THAT EXIST TO ENSURE THE PEACEFUL WORKINGS, MUTUAL RELATIONS BASED ON LAW AND INVIOLABLE RESPECT FOR SOVEREIGNTY OF THE COUNTRIES OF THE WORLD. THESE INTERNATIONAL LAWS AND STANDARDS, IN THE END SERVE TO GUARANTEE THE EXISTENCE OF THE ENTRIE FAMILY OF NATIONS.

THIS IS A LIVING DOCUMENT AND IN NO WAY PRETENDS TO BE A DEFINITVE LEGAL WORKING DOCUMENT READY FOR SUBMISSION TO LEGAL BODIES BUT RATHER A TEMPLATE IN ORDER TO GATHER THE REQUIRED SUPPORT THAT WILL BE REQUIRED TO MOVE ANYTHING OF THIS SIZE OR IMPORTANCE AHEAD. THE ASSISTANCE OF THE GREATEST LEGAL MINDS IN HISTORY WILL BE REQUIRED AND EXTREMELY BROAD INTERNATIONAL SUPPORT ON EVERY LEVEL WILL BE NEEDED AS VIOLENT OPPOSITION TO THIS DOCUMENT IS TO BE EXPECTED AND MUST BE PLANNED ON. THEREFORE CONFIENTIALITY IS IMPORTANT.

THE BASIS FOR THIS DOCUMENT

This declaration also referred to herein as this "document", has been formulated with the belief in and under the following principles:

That truth and justice are of primary importance and take precedence over procedure, subterfuge and Machiavellian legal language used to hide and "legalize" the commission of crimes especially the ones covered in this document. The elites and the hose behind the N.W.O. must no longer be allowed to hide behind financial and legal complexities to befuddle and rob the good peoples of the world,

That new legal structures which actually serve justice and truth are needed and must be formed along the lines of common law to replace admiralty and corporate law, given the clear failure and bias of the United Nations, the International Criminal Courts at the Hague and all current enforcement bodies,

That the sovereign people of any nation must be free from interference, pressure and outside meddling in their internal affairs and most importantly in their internal political processes, this includes but is not limited to: freedom from being pressured to join military blocs or alliances, freedom to choose association with economic and geo-political blocs that serve the interests of the sovereign people and nation, not those of elitist bankers and politicians,

That the ultimate authority on any sovereign territory is the native and the true sovereign, this means an end to colonial powers as the masters of conquered territories as this document seeks to strip away the extra-territorial self-given right of one power to subject and colonize a second or third sovereign power,

That no culture must force or attempt to force another to accept its own standards with regards to norms in human rights or societal standards. Countries which choose to adopt freely and of their own free will declarations or norms may do as they see fit. Again that is the choice of each sovereign nation but no nation must try to force another to accept things like gay marriage, pedophilia and the like,

That all nations and all peoples are equal and that no nation has the right to inflict economic, military or other harm on another in order to get it to follow its dictates or abide by its rules. This cancels the practice of sanctions, so called humanitarian intervention, regime change, color revolution operations, subversion, assassinations of heads of state and political rivals and other such activities which have become the norm in today's world. This also cancels the ridiculous practice of the United States in trying to subject citizens of other countries to its own laws as if its laws apply to the world,

That no country or extra national power serving hidden masters has the right to influence or manipulate any other country's economic, manufacturing or resource potential. This ends several illegal practices that have become the standard of the day for the N.W.O including the Rothschild Central banking scheme, the petro-dollar resource scheme and the NATO protection for percentage of GDP scheme.

That no extra territorial block has the right to strip away or infringe on the culture, beliefs or standards in society that makeup any other sovereign nation. This includes forcing the acceptance of languages, religions and any other things which affect or damage the character and inviolable essence of a people and their culture,

That we as human being are all equal regardless of color of skin, religion or other standard or belief and that those of us more fortunate have an obligation to help those around us who are less fortunate. Thus no one individual or family or grouping can possess or hoard riches, territories, properties or resources, meaning anything that can be counted as wealth, while other humans are starving, living in poverty or conditions not fitting for a human being. This will force the Rothschild family whose wealth is reported to be at 500 trillion dollars, the British Royals and other members of the upper 1% to divest their wealth and have it redistributed to the people of the world who they have exploited for far too long. This will also force war profiteers and those profiting on the destruction of countries and societies such as George Soros and other elites to pay restitution and rebuild the countries they have so callously destroyed or attempted to possess or use as resource donors. This means the US must rebuild every country it has ever bombed, period,

That no country (i.e. Saudi Arabia, the United States, Israel), military block (i.e. NATO) or political alliance the (i.e. the EU) has the right to wage war or attack any other to affect regime change or some other objective. Military force against ANY country by another must be only in answer to a direct military attack with proper proof and the agreement of the entire family of nations. The declaration of threats such as cyber-attacks, false flag terror attacks where direct irrefutable proof is not offered and other self-serving unilaterally claimed reasons can no longer be allowed as a catalyst to be used to invade or attack other countries. This will end the US/NATO/Israeli/Saudi actions and interventions in the Middle East, against North Korea, Syria, Ukraine, Yemen, Palestine and the other two dozen or so locations where the US is currently involved in wars by proxy or directly on false pretenses.

That no country has the right to arm, fund, support or otherwise aid any internal military force within any country that is waging war or bent on waging war in an internal conflict. Outside intervention can only be in the form of real peace keeping operations. This will end all Western operations all over the world in particular in Syria, Iraq, Afghanistan, Libya, Ukraine and Somalia.

That threats of war or invasion or assassination or the killing of citizens as an instrument of applying pressure can no longer be tolerated and those doing so must be held criminally accountable by the family of nations. This means the United States in particular can no longer go around making statements that they will assassinate leaders, invade or "intervene" in countries and other such practices,

That the events of 911 be investigated and prosecuted by uninvolved non-biased international parties and that those who are truly guilty be brought to justice. This also applies to other internal, in particular US scandals, that have an international component. Including but not limited to the international child trafficking, rape and murder scandal known as Pizzagate. Since these crimes allowed the US/NATO to start endless illegal wars and adversely affect the lives of international humans they are no longer the legal domain of the United States itself and thus such crimes must have a legal body to prosecute them,

That no country's intelligence agency or other body can spy on, assassinate, kidnap, subvert, or otherwise inflict harm or manipulation on the citizens, governments or territories of other countries. This will seek to end the NSA/CIA/FVEY network which seeks to facilitate the control of the entire planet and spies on anyone anywhere anytime,

That no country has the right to kidnap, imprison, torture, detain or otherwise interfere with the citizens of another country if that citizen is not on their sovereign territory. Thus no country may possess or maintain secret prisons, torture facilities or other such locations on territory outside its own borders. This will end the practice of rendition, close the illegal torture prison at Guantanamo and once and for all stop the US from interfering with the citizens of the world as they go about their daily lives outside the United States. This will also allow Julian Assange safe passage to his country of refuge.

That no country, no matter what the pretext, has the right to take human life and if it does so must be isolated from the family of nations, in this regard no country has the right to take the human life of other country's citizens as well. Unless there is a legally defined state of war and the targets are armed soldiers who can properly and equally defend themselves. This will require a reworking of the rules of war and will end the highly illegal practice of extra-judicial execution that is the US droning program and the endless bombing of civilians by the United States. These cowardly practices must end,

That religion can no longer be used as a basis for the invasion or occupation of any other territory or the taking of human life no matter what the reasoning is. Any such country or ideology or religion professing to be chosen by God or possessing the right to take human life, thereby abdicating "God" of his own right cannot be allowed to do so, or similarly stating that territory was given to them by "God" when "God" already placed sovereign people on it, must not be allowed to any longer do so. This ends the false claims by the fictitious state of Israel, the Saudi Royals, the United States of America and other European powers who have used documents such as the Doctrine of Discovery to commit genocide and occupy territories in the Americas, Australia, New Zealand and other parts of the former and present British Empire. This will

return said territories to the sovereign peoples, in particular North America and Palestine.

This document in effect seeks to end empire and empower sovereign peoples to possess a choice either through referendum or other method to choose their own leaders and their own sovereign destinies and make the world multipolar. It also seeks to reform or replace the United Nations since it has failed in its core mission

MORE POINTS TO BE ADDED BY INTERESTED PARTIES AND AS THEY COME IN

A SOVEREIGN WORLD ORDER

Again this is a living document and I hope there will be a healthy amount of interest and cooperation into making it become a reality and ending the illegality and wars that have plagued the world for the last decades.

We know that the New World Order they talk about is just a continuation of the Old World Order, meaning the British Empire, and we choose to end that order today. This document seeks to lay the ground work for unification and empowerment of smaller countries and colonized powers and end the reign and manipulations of the Rothschilds, Soros, the British elites and what are known as Globalists. Their assets internationally are to be nationalized by prospective countries and their operations are to be ended immediately.

On the role of the Sovereigns of Turtle Island.

The peaceful sovereigns of North America having been the victims of the most horrendous genocide in history and will have a leading role in formulating a peaceful sovereign world order in particular when dealing with their sovereign territories and in the area of human rights.

On the Role of the Russian Federation.

The sovereign nation of the Russian Federation which has shown that it respects the sovereignty of nations and the sovereign peoples of the world regardless of religion will play a leading role in formulating a peaceful sovereign world order. Russia and the People's Republic of China are crucial to this document because they are the most powerful counter weight to the aggressions and expected violent resistance which will be encountered if this document is to be in any way implemented.

Russia has the experience and know-how to assist in formulating international bodies of justice and ensuring the disarming of violent factions and the dismantlement of the NATO war monster and the closure of US bases all over the world, which will be necessary and which are simply instruments of their empire.

On the role of the United Nations and International Legal Bodies

The United Nations, if it can be saved and be restored to its original meaning instead of a rubber stamp for US/Israeli crimes, must be moved to a neutral country and all influence and ties to the US and Israel which are used to influence the body must be cut. The United Nations has proven and even by the words of its own employees that it is simply an instrument of the US and Israel for projecting their power and hiding their crimes.

If bodies are to be maintained, the United States, factually guilty of multiple acts of aggressive war and thousands of other egregious international crimes, must be removed from the Security Council. Israel guilty of genocide on the Palestinian people and guilty of occupying a foreign territory must also be removed from the United Nations as must the Sunni Saudi Arabia due to its human rights abuses, sponsorship of terrorism and participation with the US and Israel in the events of 911.

On the role of the international community, all countries of the world will have equal voices in all bodies of the United Nations or the new body that must be formed to replace the United Nations.

On the role of Citizens of the United States of America, Canada and other territories gained through subterfuge by the British Crown, the Rothschild Family, International Banking and resource cartels, military blocs such as NATO and other extra-national bodies and organizations which seek to control the sovereign nations of the world.

First: Given that the United States is beholden to Israel and using their own logic, the illegal "Doctrine of Discovery", the United States of America and the secret Corporation of the UNITED STATES OF AMERICA, the legal body owned by the Rothschilds and the British Crown: the United States in all its forms can no longer claim the right to the territory of the sovereign nations under the Doctrine of Discovery for the sole reason that it is no longer, through the actions of its leaders, a Christian Nation under the Catholic Church. That is reason one. The Doctrine of Discovery must and will be annulled and therefore any claim under it will also. Finally since the United States has failed to adhere to the treaties with the sovereign nations of North America, they no longer have the right to occupy the territories and must return control immediately.

With the universal belief that all people are equal and whereby no country or power is above international law or can take away the rights of any other people and that no country or power may ignore the norms and standards accepted by and followed by the Family of Nations

DECLARATION ON THE DISSOLUTION OF THE UNITED STATES
OF AMERICA AND ITS ASSOCIATED MILITARY AND OTHER
GLOBAL STRUCTURES DEEMED TO BE A HARM TO THE
FAMILY OF NATIONS, THE BREAKING UP OF NATO, THE
LIQUIDATION OF THE ILLEGAL STATE OF ISRAEL, THE STOP OF
MILITARY PREPARATIONS FOR WORLD WAR III, THE END TO
ALL STATE SUPPORT OF TERRORISTS GROUPINGS, THE
RESTITUTION TO AND REBUILDING OF COUNTRIES
ADVERSELY AFFECTED BY THE POLICIES AND ACTIONS OF THE
UNITED STATES, ISRAEL, SAUDI ARABIA AND THEIR AGENTS
AND FOR THE FORMATION OF INTERNATIONALTRIBUNALS
AND PROSECUTIONS FOR CRIMES AGAINST HUMANITY,
CRIMES AGAINST PEACE, ILLEGAL DETENTION, TORTURE AND
THE STATE SPONSORED TERRORIST EVENTS OF 911.

LEGAL REASONS FOR INTERVENTION AND IN SUPPORT OF THIS DOCUMENT AND DECLARATION:

Point One: Attempting to Take Over the World by Force (Global Hegemony)

Whereby we the undersigned declare that: The CORPORATION OF THE UNITED STATES OF AMERICA is engaged in an illegal, ongoing, self-admitted, proven and documented attempt to "establish global hegemony by force" which runs contrary to all international norms and standards and violates the very core idea behind the foundation of the United Nations and all laws, agreements and standards that govern relations amongst members of the family of nations.

Being thus this must be stopped, and the UNITED STATES OF AMERICA isolated and brought in line with civilized standards using all means necessary.

Point Two: Multiple Counts of Aggressive War, Undeclared War, Illegal Wars

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA is beyond a reasonable doubt guilty of multiple instances of the crime of Aggressive War which is a Crime Against Peace and the worst crime that can be committed against all of humanity.

Therefore tribunals must be formed, all undeclared wars that are not purely in the classical sense under the rules of war "defensive" must be stopped and the guilty brought to justice.

Point Three: September 11, 2001

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA and its agents and allies are evidenced to have staged the controlled demolitions of the Word Trade Center buildings and the accompanying massmurder of approximately 3,000 people on September 11, 2001. The destruction of all WTC buildings and the other related false flag attacks

covered up the theft of trillions of dollars and mercilessly killed thousands and then were used as a pretext to begin a campaign of aggressive war for global domination and endless war profiteering. These wars must be stopped immediately and all crimes prosecuted.

The evidence over time has shown us the beneficiaries of these events and those guilty of their organization include the reported owner of the legal entity THE CORPORATION OF THE UNITED STATES OF AMERICA, or UNITED STATES INC registered with the City of London, Lord Jacob Rothschild, the illegal apartheid state created by the Rothschild family Israel, the Kingdom of Saudi Arabia and its networks of terrorists and a network of high-level US Intelligence and Military Industrial Complex figures loosely labeled the NeoCons. All of whom effectively took over the US Government in an illegal coup.

The guilty parties are also to be tried for the crimes of genocide, aggressive war, torture, running an illegal extra-territorial torture prison, massive theft, subversion of democratic governments, illegal interference with investigations, the use of illegal weapons and technology causing mass death, extra-judicial execution and all charges related to the illegal plans to commit the crime of aggressive war on 7 countries in 5 years for the Israeli beneficiary and all related profiteers. All bodies, states and individuals involved and who profited including NATO must be found and brought to justice.

Note: While the US, Israel, NATO, Saudi Arabia and their criminal coconspirators may say 911 was strictly an internal matter, as it involved citizens from all over the world, benefitted non-US entities and resulted in endless global undeclared illegal war, it has clearly become a matter for international investigation and the forming of international tribunals to punish the guilty is the only logical solution as the guilty will never prosecute themselves.

Point Four: Supporting, Sponsoring, Funding and Using Terrorism

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA, NATO, Israel and Saudi Arabia, as evidenced by a massive trove of

documentation, financial flows, their own actions and statements and a body of evidence too voluminous to list here, are guilty of sponsoring, financing, arming, training, recruiting, providing military support and using terrorists and terrorism in order to meet their international, internal, geopolitical, extraterritorial, economic and resource objectives.

The guilty parties have from the beginning of their so-called "War on Terror" avoided clearly defining what a terrorist is for the intentional purpose of avoiding responsibility and in order to facilitate what has clearly become the genocide of entire peoples along ethnic, religious and territorial lines.

Therefore again tribunals must be formed, international police bodies must be gathered and empowered and if necessary an international military force must be organized to deal with, apprehend, arrest, liquidate and otherwise neutralize the guilty parties and this ongoing risk to all peace loving members of the global family.

Point Five: Torture and Maintaining Illegal Prisons to Torture

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA is clearly guilty of running government sponsored torture programs, torturing innocent individuals who had no legal recourse, protection or even trials, murdering or permanently illegally detaining such victims and covering up and maintaining illegal torture sites worldwide. First and foremost is the illegal torture prison located at Guantanamo Bay Cuba.

This facility and all other such sites must be closed immediately, all victims allowed recourse, restitution and rehabilitation and all of those guilty brought before a special tribunal which must be formed to specifically deal with this issue.

Point Six: Extrajudicial Execution, Remote War and Droning

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA is guilty of manipulating new technology and technological advances to wage an

illegal global war that is illegal under the Rules of War as it has allowed the US to kill adversaries and for the most part civilians without itself being at risk itself by hiding in bunkers in the United States. Through their "Drone Program" they have engaged in the crime of extra-judicial execution on "suspects" who the U.S. believes, not being US nationals, they can just execute as they see fit on the most minimal of evidence and without trial or the redress. The taking of human lives under such a scheme is in violation of every normal human right and judicial standard and labelling their targets suspected "terrorists" in no way justifies this tactic or makes it acceptable to civilized people.

A special tribunal must be formed to address these issues, all infrastructure allowing the US to carry out such crimes must be liquidated or destroyed and all those guilty must be tried and brought to justice. All victims must be allowed redress and their families and those affected must be paid restitution and have property destroyed by such attacks replaced.

Point Seven: Openly Assassinating or Removing World Leaders

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA is regularly guilty and even brags and speaks openly of assassinating and/or removing leaders of sovereign nations in order to fit its own geopolitical preferences as it sees fit.

This violates and international and sovereign norms and standards and cannot be accepted in anyway by the family of nations. The evidence we have includes cancer assassination programs, organized planes crashes and many more and clearly shows that the US and its allies and associated intelligence agencies including a group of assassins working for the World Bank named the Asteroids regularly engages in the assassination of leaders.

History has shown that when unsuccessful the US may implement color revolution strategies or openly invades countries such as Syria on prefabricated and false evidence and as we have seen using terrorists in their employ to carry out provocations to allow for military actions aimed at removing the leader in question. This practice in unacceptable and must be stopped.

All cases where this is suspect, such as the deaths of Hugo Chavez and Yasser Arafat must be investigated and brought before a tribunal specially gathered to hear such cases and those guilty must be brought to justice.

Point Eight: Color Revolutions and Destabilization Operations

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA is guilty of regularly organizing and causing the destabilization of countries and color revolutions to bring about a change in power to one that is more to the liking of the Unites States. This goes against the very spirit of sovereignty enshrined in the UN Declaration and runs contrary to all internationally accepted norms, laws and standards that control the relations between all countries in the family of nations.

A tribunal must be formed and those guilty brought before it and punished and all organizations and NGOs involved in such practices must be broken up. The countries affected are also eligible for restitution, compensation for damages incurred due to these operations and guilty parties must be held criminally liable. George Soros and such sponsors who are well known to the Intelligence Community must be arrested and held responsible for the death and suffering they have caused in their cynical attempts to rule the world.

Point Nine: Payment for Destroyed Infrastructure

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA, due to its policies of aggressive war, color revolutions, regime change and subversion has caused irreversible harm to the infrastructure and the ecologies of the countries it has invaded. Through the use of illegal depleted uranium munitions for example and the illegal targeting of civilian infrastructure, the actions of the US have caused immeasurable harm to the lives of the populations of its targeted countries and their lands.

Tribunals and expert groups must be formed and the United States must be made to facilitate reconstruction, clean up and repair for damage it has caused with all costs being born solely by itself including normal compensation for pain, suffering and all forms of loss.

Point Ten: Organized Genocide, Support of Genocide or Genocidal Polices

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA is guilty of the crime of genocide on multiple populations, either outright or through subversion, medical means, poisoning of food and water supplies or destruction of infrastructure including the continuing genocide of the Indigenous populations and First Nations Peoples of the Americas.

Systematic genocide is being carried out on First Nations though various methods including through the disappearing of women and girls, the poisoning of water supplies and the introduction of cancers and other diseases which have all been documented and proven to have been carried out in an institutionalized and methodical manner.

Genocide by the United States has also been carried out on the populations of Serbia, the Donbass Region of Ukraine, the Middle East, Palestine, Somalia and other countries to be added in the final draft. It is also important to include the systematic policies that the West and the masterminds of the N.W.O. have implemented to lower birth rates and lead to the eventual extinction of the Russian and Slavic people.

The formation of a tribunal and working group which will determine further measures and what is needed to undo the damage that has been done must be carried out and corrective measures implemented.

Point Eleven: Resource Theft and Economic Subversion, Exploitation

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA is guilty of the economic and other subversion of societies and economies on a global scale. The exploitation, stealing or dishonest acquisition of natural,

mineral or human resources has been standard operating practice for the U.S. and its corporations and must stopped and the U.S. isolated from doing so further including through corporate, trade, military or other methods.

Point Twelve: The Illegal Annexation of Palestine and Systematic Genocide

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA and the United Kingdom are guilty of supporting and arming an illegal nuclear power and are in collusion with the illegal annexation of Palestine for the illegal state of Israel.

By its own actions, through aggressive expansion, the promotion and use of terrorists to gain territory and its systematic genocide of the Semitic Palestinian people, Israel has revoked any right it had been granted illegally by the ridiculous three-sentence Balfour Declaration whereby the Brtish Crown gave Lord Rothschild the right to annex Palestine, a right over a sovereign nation that they did not have to give under all normal and healthy standards and in contrary to this document and it very foundation.

Therefore the so-called State of Israel must be peacefully disbanded and all territories and lands returned to the Palestinians who also must receive restitution and the right to possess all built up infrastructure built on their land with no damage or retribution by the vacating "settlers".

An international force and international tribunals must be formed and Lord Rothschild, the Zionist International and all other bodies occupying and settling Palestine must be forced to provide Palestinians and their families and heirs with restitution and compensation for their moral and material losses.

Point Thirteen: Indigenous Declaration of Sovereignty

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA is guilty of violating all of the original treaties allowing for it to continue to continue to occupy the territory of North America including but not limited to the Doctrine of Discovery which was formulated by the Roman Catholic

Church, an outside power which had given itself domain and in fact had no right to do so. There is also the argument that the US is no longer a Christian Nation but instead one beholden to and in fact owned by a Zionist master Lord Rothschild, hence the Doctrine no longer applies in anyway shape or form if it did in the first place.

Therefore the Doctrine of Discovery must be annulled and all subsequent treaties and agreements also annulled since they were not followed and were in fact not reached in good faith but were merely vehicles for lies and subversion to take away the lands of the sovereign nations.

The First Nations must be returned control of all territories of North America complete with buildings, structures and anything else built on them the value of which will be calculated against the debts of hundreds of trillions of dollars that the Corporation of the United States has to the First Nations.

The officials laws will be those of the First Nations and all decisions regarding populations, rights governments and control will be decided by the First Nations as they see fit being as the territory is theirs to manage and take care of. Tribunals, Commissions and Bodies must be formed under the guidance of the first nations and the powers who are signatory to this document.

Point Fourteen: Illegal Global US and NATO Military Expansion

Illegal NATO Global Military

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA, it military forces and its international military wing NATO have been engaged in an attempt at documented world takeover and use their military not for defense or security of populations but for the grabbing of resources, the changing of regimes and the stealing of the GDPs of member countries in what can only be described as a protection racket.

With regard to European countries the loss of sovereignty and the 2%-7% of GDP the countries must pay annually is outrageous given that we know there is no real threat and NATO is an anachronism of the Cold War that was never

needed to begin with. The fact that NATO destabilizes and cause war and havoc wherever it goes can no longer be allowed to stand or be used as a self-serving rationale for its continued existence. NATO is not needed and is in fact the biggest threat to world security that we have today other than illegally nuclear armed Israel and the aggressive war conducting United States.

This document and the points it contains regarding the inviolability of sovereignty, the prohibition of war and sponsoring terrorists and the other points negates the fictitious need for the continuation of the anachronism of NATO.

Under this clause all US military bases worldwide must be closed and the territories returned to their respective countries. This includes in particular Kosovo and Camp Bondsteel which must be returned to Serbia as the United States and NATO had no right to give it to the Albanian side. It is historically Serbian and the Serb people are the sovereign hence under this declaration they must have the right to their own territory.

Commissions, bodies and tribunals must be formed to try the NATO and Albanian aggressors outside of the biased structure that is The Hague.

Point Fifteen: Illegal Military Racket

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA must be prevented from running arms rackets and promoting, instigating and starting wars to sell arms.

This point will be expanded on in the future but it will reign in the Military Industrial Complex which has become a self-sustaining global power in its own right to the detriment of the human population of the planet.

Point Sixteen: Cultural Genocide, Europe and the World

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA though its policies, media and information control and the special operations

of its intelligence services is engaged in the cultural genocide not only on itsd

own indigenous and other populations but on the global populations in Africa,

the Americas, Asia, Europe and the rest of the world.

Under the spirit of this declaration all countries have a right to their own

sovereign cultures and customs and that right must be protected. We are clear

on the plans of the N.W.O. and reject their view of a global homogenous

Anglo-Judeo society. This cannot be accepted.

Expert groups and representatives from all countries must be organized to

implement solutions to this very important problem.

Point Seventeen: Sanctions

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA

and its self-endowed practice of legalized theft which it calls sanctions must be

stopped immediately. In the spirit of this document no one country has the

right to declare themselves the moral policeman of the world and allow itself

to steal the financial or other resources of another country because that

country is not following the instructions of the United States.

In this regard all global financial institutions must be made independent of the

United States, again demanding an end to the Rothschild Central Bank System.

It can be under this point or any other in this document that the Rothschild

Global Central Bank racket must be eliminated. All sovereign countries must

have their own sovereign banks, all Rothschild funds inside these countries

must be nationalized and where necessary Rothschild must pay restitution to

countries which he has, for lack of a better term, robbed.

New international banking bodies and currencies will have to be implemented

and organized.

Point Eighteen: The Ukraine

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA and NATO and the EU have carried out an illegal regime change operation and organized the armed military coup of a sovereign nation and are currently involved in the ethnic genocide of the Russian speaking population of Donbass and Ukraine.

We demand an end to any and all US involvement in Ukraine including a return of the Ukrainian Gold Reserve which was expropriated to the United States and an end of CIA and US involvement in the fratricidal war that they started there.

The formation of international war crimes tribunals is needed and international bodies to guarantee that restitution and reconstruction of Ukraine is paid for and carried out by those who are guilty of destroying it.

Point Nineteen: Syria

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA, Israel, NATO and their allies have been engaged in a decades long attempt to destroy the sovereign country of Syria for their own geopolitical, territorial and financial gains. The horrendous crimes including the murder of 426 children in Latakia, Syria, carried out by terrorist grouping sponsored by the CIA and MOSSAD must be punished and those responsible brought to justice.

In the spirit of this document US officials, all the way up the chain of command must be held accountable. This includes US Presidents present and past, heads of the military and the CIA.

Any and all involvement by the West in Syria, covert and overt, is illegal and must be stopped immediately.

Point Eighteen: Saudi Arabia

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA has just promised Saudi Arabia \$380 billion in arms which it will use to

continue its illegal aggressions in the Middle East for Israel and the United States.

We demand that all weapons shipments to Saudi Arabia be stopped and its aggression against the smaller and defenseless Yemen also stopped and that Saudi Arabia be sanctioned and excluded from the United Nations for its continued practice of beheading and executions. Saudi Arabia has violated one of the key tenets of this document that all human lives are equal and has abdicated unto itself the role of God.

Commissions must be formed and defense of Yemen and the prevention of the attack on Iran must be a priority for the family of nations. Saudi Arabia must pay restitutions to Yemen and the Yemeni people and rebuild everything it has destroyed in the country.

Point Nineteen: Secret Societies

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA and its partners through the use of secret societies and secret grouping has cause irreparable harm to the family of nations. It is largely through thewse groupings and societies that human, drug, organ and other trafficking are affected and this is something that has to be stopped at once.

International investigative bodies and tribunals and expert groups must be formed.

Point Twenty: Sanctions

Whereby we the undersigned declare that: The UNITED KINGDOM and the ROTHSCHILD FAMILY through the scheme of central banks and the pricing of gold have obtained immeasurable wealth and control of the world and we declare that this must be stopped at once and all countries harmed by these schemes be paid restitution and the Rothschild family and all other such groupings be banned from the financial sphere and from carrying out similar schemes.

Expert groups and policing bodies must be organized and their illegally obtained wealth divested back to the peoples of the world.

Point Twenty-One: Apartheid States

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA, the fictitious STATE OF ISRAEL and the KINGDOM OF SAUDI ARABIA are illegal repressive apartheid systems, existing on sovereign territories not their own and must be dismantled and control handed over to the sovereigns.

Bodies and commissions and enforcing organizations as well as military and peace keeping bodies will be needed.

Point Twenty-Two: Media and Mind Control Operations

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA and its partners including largely Zionist interests are manipulating and have taken control of the world's media and are attempting to control the Internet and all forms of communications between peoples in sovereign nations.

Through the use of censorship, search engines and social media we know that the United Sates, the CIA, MOSSAD and other groupings use the Internet and the media to cause social discontent, recruit terrorists and as a catalyst for color revolutions. We also know that through the use of information manipulation and the publication of lies and propaganda the CIA, NATO and MOSSAD have weaponized the Internet, conducted military grade psychological operations and have used it as an instrument to facilitate war!

We believe the Internet must be free and must not be used and that control of media and journalism must be returned to independent media outlets and not intelligence agencies.

New protocols, bodies and expert groups will be needed to carry this out effectively.

Closing

Whereby we the undersigned declare that: The UNITED STATES OF AMERICA has caused damage to the following countries whom we invite to submit evidence and additional points to this declaration. We declare that the United States of America has organized coup d'états, supported revolutions, overthrown governments, invaded, annexed, supported groups or forces who overthrew or attempted to overthrow governments or outright executed the leaders of the following countries: Afghanistan, Albania, Angola, Argentina, Bolivia, Bosnia, Brazil, Cambodia, Chile, China, Colombia, Congo, Cuba, the Dominican Republic, Egypt, El Salvador, Germany, Greece, Grenada, Guam, Guatemala, Haiti, Hawaii, Honduras, Indonesia, Iran, Iraq, Korea, Kuwait, Laos, Lebanon, Liberia, Libya, Macedonia, Mexico, Nicaragua, Oman, Pakistan, Panama, Philippines, Puerto Rico, Russia, Samoa, Saudi Arabia, Somalia, Sudan, Syria, Turkey, Ukraine, Uruguay, USSR, Venezuela, Vietnam, Virgin Islands, Yemen, Yugoslavia and Zaire (Congo).

Thus all military activities by the United States must be halted immediately.
