How can we do something? What can we do? We're suing them in a multi-million-dollar bribery case.

I'm also one of four members of the German Corona Investigative Committee. Since July 10, 2020, this committee has been listening to a large number of international scientists and experts' testimony - to find answers to questions about the corona crisis which more and more people worldwide are asking. All the above mentioned cases of corruption and fraud committed by the German corporations pale in comparison in view of the extent of the damage that the corona crisis has caused and continues to cause. This corona crisis, according to all we know today, must be renamed a corona scandal; and those responsible for it must be criminally prosecuted and sued for civil damages.

On a political level, everything must be done to make sure that no one will ever again be in a position of such power as to be able to defraud humanity, or to attempt to manipulate us with their corrupt agendas. And, for this reason, I will now explain to you how and where an international network of lawyers will argue this biggest tort case ever - the corona fraud scandal - which has meanwhile unfolded into probably the greatest crime against humanity ever committed.

Crimes against humanity were first defined in connection with the Nuremberg trials after World War II, that is when they dealt with the main war criminals of the Third Reich. Crimes against humanity are today regulated in section 7 of the International Criminal Code.

# The current state of affairs: 1. How dangerous is the virus really? 2. What is the significance of a post-positive PCR test? 3. What collateral damage has been caused by the corona measures?

#### 1. How dangerous is the virus really?

The current, actual situation regarding the virus's danger; the complete uselessness of PCR tests for the detection of infections; and the lockdowns based on non-existent infections ... health care systems were never in danger of becoming overwhelmed by COVID-19 ... Studies carried out by Professor Ioannidis and others have shown that the mortality of corona is equivalent to that of the seasonal flu; even the pictures from Bergamo and New York that were used to demonstrate to the world that panic was in order proved to be deliberately misleading

Now, let's take a look at the current, actual situation regarding the virus's danger; the complete uselessness of PCR tests for the detection of infections; and the lockdowns based on non-existent infections.

In the meantime, we know that the health care systems were never in danger of becoming overwhelmed by COVID-19. On the contrary, many hospitals remain empty to this day and some are now facing bankruptcy. The hospital ship Comfort which anchored in New York at the time, and could have accommodated a thousand patients, never accommodated more than some 20 patients. Nowhere was there any excess mortality.

Studies carried out by Professor Ioannidis and others have shown that the mortality of corona is equivalent to that of the seasonal flu; even the pictures from Bergamo and New York that were used to demonstrate to the world that panic was in order proved to be deliberately misleading.

The accompanying irresponsible statements of the head of the RKI, remember the CDC, Mr Wieler who repeatedly and excitedly announced that the corona measures must be followed unconditionally by the population, without them asking any question shows that he followed the script verbatim. In his public statements he kept announcing that the situation was very grave and threatening although the figures compiled by his own institute proved the exact opposite.

A word of clarification: in Bergamo, the vast majority of deaths, 94 percent to be exact, turned out to be the result, not of COVID-19, but rather the consequence of the government deciding to transfer sick patients, sick with probably the cold or seasonal flu, from hospitals to nursing homes - in order to make room at the hospitals for all the COVID-19 patients, who ultimately never arrived. There at the nursing homes, they then infected old people with a severely weakened immune system, usually as a result of pre-existing medical conditions, in addition, a flu vaccination which had previously been administered had further weakened the immune systems of the people in the

nursing homes.

In New York only some, but by far not all, hospitals were overwhelmed. Many people, most of whom were again elderly and had serious pre-existing medical conditions and most of whom had it not been for the panic mongering would have just stayed at home to recover, raced to the hospitals. There many of them fell victim to healthcare-associated infections, or nosocomial infections on the one hand and incidents of malpractice on the other hand, for example: by being put on a respirator rather than receiving oxygen through an oxygen mask.

To clarify, COVID-19, is a dangerous disease, just like the seasonal flu may sometimes take a severe clinical course and will sometimes kill patients. However, as autopsies have shown, almost all been caused by serious pre-existing conditions and almost all of the people who had died, had died at a very old age, just like in Italy, meaning they had lived beyond their average life expectancy

Again to clarify, COVID-19, this is the current state of affairs, is a dangerous disease, just like the seasonal flu is a dangerous disease and of course COVID-19, just like the seasonal flu may sometimes take a severe clinical course and will sometimes kill patients. However, as autopsies have shown, which were carried out in Germany, in particular by the forensic scientist Professor Klaus Püschel, in Hamburg, the fatalities he examined had almost all been caused by serious pre-existing conditions and almost all of the people who had died, had died at a very old age, just like in Italy, meaning they had lived beyond their average life expectancy.

In this context the following should also be mentioned: the German RKI, that is again the equivalent of the CDC, had initially, strangely enough, recommended that no autopsies be performed and there are numerous credible reports that doctors and hospitals worldwide had been paid money for declaring a deceased person a victim of COVID-19 rather than writing down the true cause of death on the death certificate, for example a heart attack or a gunshot wound. Without the autopsies we would never know that the overwhelming majority of the alleged COVID-19 victims had died of completely different diseases but not of COVID-19.

The assertion that the lockdown was necessary: a) the lockdown was imposed when the virus was already retreating, & b) There's already protection from the virus because of cross or t-cell immunity

The assertion that the lockdown was necessary because there were so many different infections with SARS-CoV-2 and because the healthcare systems would be overwhelmed is wrong, for three reasons, as we have learned from the hearings we conducted with the Corona Committee and from other data that has become available in the meantime.

- a) the lockdown was imposed when the virus was already retreating. By the time the lockdown was imposed the alleged infection rates were already dropping again.
- b) There's already protection from the virus because of cross or t-cell immunity, apart from the above mentioned lockdown being imposed, when the infection rates were already dropping there is also cross or t-cell immunity in the general population against the coronaviruses contained in every flu or influenza wave. This is true, even if this time around a slightly different strain of the coronavirus was at work, and that is because the body's own immune system remembers every virus it has ever battled in the past, and from this experience it also recognises a supposedly new but still similar strain of the virus from the corona family.

#### 2. What is the significance of a post-positive PCR test?

THE PCR TEST -- the PCR test for the detection of an infection was invented by the now infamous Professor Drosten ... Then he sent it to China to determine whether the victims of the alleged new coronavirus tested positive. Incidentally that's how the PCR test for the detection of an infection was invented by the now infamous Professor Drosten. At the beginning of January of 2020, based on this very basic knowledge, Mr Drosten developed his PCR test which supposedly detects an infection with SARS-CoV-2. Without ever having seen the real Wuhan virus from China, only having learned from social media reports that there was something going on in Wuhan, he started tinkering on his computer with what would become his corona PCR test.

For this he used an old SARS [severe respiratory syndrome] virus hoping it would be sufficiently similar to the allegedly new strain of the coronavirus found in Wuhan. Then he sent the result of his computer tinkering to China to determine whether the victims of the alleged new coronavirus tested positive. They did, and that was enough for the WHO to sound the pandemic alarm and to recommend the worldwide use of the Drosten PCR test for the detection of infections with the virus now called SARS-CoV-2.

Drosten's opinion and advice was, this must be emphasised, once again the only source for the German Government when it announced the lockdown, as well as the rules for social distancing and the mandatory wearing of masks; and this must also be emphasised once again, Germany apparently became the centre of, especially, massive lobbying by the pharmaceutical and tech. industry because the world, was referenced to the allegedly disciplined Germans, should do as the Germans do in order to survive the pandemic.

c) And this is the most important part of our fact-finding. The PCR test is being used on the basis of false statements, not based on scientific facts with respect to infections. Drosten, Wieler and the WHO, do not give any indication of an infection with any virus let alone an infection with SARS-CoV-2.

Note: not only are PCR tests expressly not approved for diagnostic purposes, as is correctly noted on leaflets coming with these tests, and as the inventor of the PCR test, Kary Mullis, has repeatedly emphasised. Instead they're simply incapable of diagnosing any disease. That is, contrary to the assertions of Drosten, Wieler and the WHO, which they have been making since the proclamation of the pandemic, a positive PCR test result does not mean that an infection is present. If someone tests positive, it does not mean that they're infected with anything let alone with the contagious SARS-CoV-2 virus.

- First bullet point says: detection of viral RNA may not indicate the presence of infectious virus or that 2019 nCoV [novel coronavirus] is the causative agent for clinical symptoms
- Second bullet point says: the performance of this test has not been established for monitoring treatment of two threat 2019 nCoV infection
- Third bullet point says: this test cannot rule out diseases caused by other bacterial or viral pathogens

PCR CYCLES -- Everything over 35 cycles is, as reported by the New York Times and others, considered completely unreliable and scientifically unjustifiable. Can that be because of the desire to produce as many positive results as possible and thereby provide the basis for the false assumption that a large number of infections have been detected?

It is still not clear whether there has ever been a scientifically correct isolation of the Wuhan virus so that nobody knows exactly what we're looking for when we test; especially, since this virus, just like the flu viruses mutates quickly. The PCR swabs take one or two sequences of a molecule that are invisible to the human eye and therefore need to be amplified in many cycles to make it visible. Everything over 35 cycles is, as reported by the New York Times and others, considered completely unreliable and scientifically unjustifiable. However, the Drosten test as well as the WHO recommended tests that followed his example are set to 45 cycles. Can that be because of the desire to produce as many positive results as possible and thereby provide the basis for the false assumption that a large number of infections have been detected?

The test cannot distinguish inactive and reproductive matter: that means that a positive result may happen because the test detects, for example, a piece of debris, a fragment of a molecule, which may signal nothing else more than the immune system of the person tested won a battle with a common cold in the past.

This could also explain the explosion of case numbers in Saudi Arabia. In addition, the media there have made this into an incredible sensation. The global population is roughly 7.8 billion people, if 10% have been infected that is 780 million cases. The global death toll currently attributed to Sars-Cov-2 infections is 1,061,539.

That's an infection fatality rate of roughly or 0.14%. Right in line with seasonal flu and the predictions of many experts from all around the world. 0.14% is over 24 times LOWER than the WHO's "provisional figure" of 3.4% back in March. This figure was used in the models which were used to justify lockdowns and other draconian policies. In fact, given the over-reporting of alleged Covid deaths, the IFR is likely even lower than 0.14%, and could show Covid to be much less dangerous than flu.

Ms Franck spoke to German Velasquez, a former WHO Director in the Public Health Department, who served during the Swine Flu pandemic. He said: "It was publicised around the world, that the criteria for declaring a pandemic were changed and at the same time the old guidelines vanished from the WHO website." Ms Franck asked: "Could they have declared the pandemic level 6 also with the old definition?" Mr Velasquez: "No, because the severity, the number of deaths, would have been a factor. "Since that was no longer one of the criteria, it made it easier to declare a pandemic." As a result of the pandemic entering a level 6 phase, the European Council later concluded that: "According to analysts, the WHO initiated spending on health measures around \$18billion (£14billion) worldwide." Ms Franck also spoke to Mr Wodarg and he revealed how the WHO had grown into a culture of secrecy and "clandestine" operations.

"The situation was evaluated correspondingly by the Council of Europe. "Reprimand was issued. "The lack of transparency, the role of the experts who were being paid by the pharmaceutical industry. "Then changes were demanded but the WHO didn't respond to the Council of Europe – the WHO turned up for the first hearing and then didn't come again. "It didn't have to, it wasn't obliged to supply us with any information. "We can't demand to confiscate the files, look through them; it is impossible, there isn't anybody who can do those things. "And there's no investigating commission like in Parliament where the MPs can go and say something has to stop and then everybody has to turn up and show their files, there's nothing like that. "The WHO can operate in a very clandestine fashion."

Respons from the pharmaceutical industry -- Motion "Inappropriate" - "In our view the terms of this motion are inappropriate for those who understand how" vaccine manufacture works, said Luc Hessel, a representative of European Vaccine Manufacturers. The vaccine industry did what was asked of them by policymakers, said Hessel. This included major investments on their part to create the vaccines, as well as the donation of 160 million doses for use in developing countries. As to profit motive, Hessel said it was still too early to determine what kind of profit had been made by industry. And most purchasing agreements were made in the third quarter of 2009, after

Dr. Wolfgang Wodarg - The King has No Clothes [Transcript]

I would like to tell you something about the coronavirus epidemic that we allegedly are having right now. First, I thought this hype is going to end again, but it has increased so much, and we finally have to start taking a closer look.

I worked as a doctor and conducted a health department. I had my own sentinel, my own monitoring system for flu diseases. And every year I observed how many people became sick in an area of 150,000 inhabitants. Every new year - worldwide - we have new types of viruses because the viruses have to change themselves. If the same viruses just came again in the next year, our immune system would recognize them so they would not be able to make us sick or to multiply - which is what they want. So they regularly have to change a bit and that's why we have new variants of these viruses every year. There are about 100 different types of viruses that are changing constantly. Up to now, we didn't really care which viruses caused this flu...or disease or however you want to call it. But there have been investigations over several years in Glasgow. There they tried to use the available tests - that means they didn't examine all 100 types, but just the ones they had tests for. So they looked at maybe 8 or10 different viruses and coronaviruses have always been a part of them. These are the figures from Glasgow. Starting from 2005 to 2013 they checked which viruses occur among respiratory diseases. And these colored columns are the viruses. The green parts refer to the coronavirus that was always in the mix. The coronavirus normally makes up 7% to 15%, maybe 5% to 14%, it always fluctuates a bit. Hence, it's just normal that a big part of viruses are coronaviruses.

So, the following happens: In Wuhan, there is the biggest safety laboratory for viruses in the whole of China. So, there are a lot of experts on the topic, dealing with it all day long. Wuhan is a big city, 11 million inhabitants, big hospitals, big intensive care units, always people being ventilated, people with pneumonia... hundreds of them and they did tests with a few patients, less than 50, looked for the viruses they had and examined their RNA in the laboratory and they found a new type. This attracted their attention. When a virologist finds something like this he puts it in a global database. And this database is accessible for scientists all over the world, in Berlin for example. In Berlin, they checked and compared this new entry and tried to create a test to measure this new variant of coronavirus.

Then Dr. Drosten submitted a protocol to the WHO, and it got admitted really quickly. Then Mr. Drosten submitted a protocol to the WHO, and it got admitted really quickly. Usually, a test is considered a product of medicine, it has to be validated. That means it has to be checked very precisely. What does the test actually say? What does it measure? The mentioned test is an inhouse-test developed in the Charite-clinic. But because there weren't any validated tests and the great panic arose, it was decided to just us this test everywhere. Then Mr. Drosten provided the test. Of course, the virologist can say if the virus is dangerous or not. He can only say: "This one is different," or "We have a test for this". But is the virus dangerous, Mr. Drosten? How is he supposed to know? He would need further epidemiological data based on observation of how sick the people are. How fast do they get healthy again? Are there fewer victims than before?

That's why it is important to look at the data from previous years to compare them. To look at the mortality rates to see how many people

died of the virus. So while looking for a specific virus, for example, the coronavirus, you can examine the total population. What you will find is that presumably 8% or 10% of the population will have some kind of virus, that makes them sick. But if you examine medical practice, do your tests there, to determine who is sick, then, of course, you would find a lot more positive cases. And if you examine hospitals and take samples there then you would find even more corona-infected people. That is to say, depending on which proportions of the population you examine - whether it is the whole population, patients in the waiting room, people in a clinic, or when you examine very ill patients in the intensive care unit that are about to die - you will expectedly find these 7% -15% coronaviruses every time you do a test. However, if they die of the coronavirus or of other viruses while just having also corona can't be determined for sure with this.

So, when you look at the death rates in Italy, you want to know where the tests have been taken. Where and how have these few available tests been used? If they were used in a hospital on serious or terminally ill cases then obviously the corona death rate rises. Just because it looked like it, because of the specific group that was examined.Mortality, disease-specific mortality, refers to the percentage of dead among the people infected with this disease. And concerning the seasonal acute respiratory disease - commonly known as the flu - there is a mortality of 0.1%, which is already the maximum. That means that one in a thousand flu-infected inhabitants die - every winter. So now we will have to see whether this number increased because of coronaviruses. The assumption for Germany is that there are 20,000 or 30,000 more deaths than without the flu. This is called excessive mortality. So now that coronaviruses always make up 5% to 14% of all flu viruses - let's say 10%. Let us assume that in the previous years we tested all seriously ill patients in the hospital on the coronavirus - which of course didn't happen - we would have expected to find 2,000 to 3,000 people dying of the flu each year, that also had the coronavirus. And we still are far away from these numbers.

Apparently, it is the case that virologists created something very sensational here, and with their creation, they really impressed the Chinese government as well. The Chinese government made something really big out of it, suddenly this was very important politically completely exceeding the virological frame. All of a sudden, face recognition was installed everywhere at the airports, fever was being measured. The clinical thermometer controlled the traffic on Chinese streets. And all this was so significant that it led to international consequences, politicians had to heal with it, had to take a stand. Then the virologist came into play again. The government asked their own virologists and they confirmed that this virus is a thing to worry about and proposed to develop tests to help measure the virus-like in China. Something was woven around this. A network of information and opinions has been developed in certain expert groups. And the politicians turned to these expert groups, who initially started all this. And they really absorbed this network, moved within it. This lead to politicians who now are just resting on these arguments, while using these arguments to evaluate who has to be helped, to determine safety measures or what has to be permitted.

All these decisions have just been derived from these arguments. This means that now it's going to be very hard for critics to say "Stop. There is nothing going on." And this reminds me of this fairytale about the king without clothes on. And just a small child was able to say "Hey, he is naked!". All the others on the courtyard - surrounding the government and asking the government for advice because they can't know themselves - they all played along and joined the hype. And like this, politicians are being courted by many scientists. Scientists who want to be important in politics because they need money for their institutions. Scientists who just swim along in this mainstream and also want their part... "We can help too!", "We made an app!", "We have a program for this!" The citizens have the right to know if there are real grounds for taking away their freedoms!

When I try discussing this with people I often get a negative reaction, they wont listen to the facts. People will say: how can you say it is not more dangerous that the normal flu? What we are hearing from independent doctors and experts is that it is not reliable, it is oversensitive, it test far more positives than is the case. I don't have to remind you of all the damage that has been produce as a result of believing WHOs exaggerated danger of corona and its spread, and governments locking down our countries for so long

- Bankruptcies of small and medium-sized businesses, which form the backbone of the economy. In Germany alone, 500 000 to 800 000 bankruptcies are expected in the fall.
